#### **Saint Vincent and the Grenadines' Disaster Relief Fund - Hurricane Beryl!!**

Hurricane Beryl impacted Saint Vincent and the Grenadines at category 4 and brought significant rainfall and heavy winds, which tore apart trees and damaged hundreds of homes and buildings.

Reports have shown devastating impacts in the Southern Grenadine Island of Union Island, where 90 percent of the homes were either severely damaged or destroyed. The Island's airport also suffered significant damage. Similar levels of devastation were reported for the Grenadine Islands of Mayreau and Canouan.

There has been a report of one fatality so far resulting from the passage of Hurricane Beryl on the island of Bequia and word of other fatalities and casualties are looming.
